NOTICE: This 2021-2022 Bosque Access Permit will be valid from April 1, 2021 – March 31, 2022

Permits are only available at the MRGCD General Office (1931 2nd St. SW, Albuquerque, NM 87102)
Monday- Friday 8:00AM- 4:30 PM

This permit must be in permitted vehicle along with the window sticker displayed in plain sight.
Transfer of permits and keys is not allowed. Keys shall not be duplicated.

The Cochiti (Pena Blanca) key will be sold separately from the Belen (Valencia/N. Socorro) key.

The MRGCD may close portions of the Bosque as needed for fire restrictions, restoration activities, facilities maintenance or other purposes with little or no notice. No refunds will be given for closures.

BOSQUE ACCESS RULES

- **MOTOR VEHICLE MAY NOT TRAVEL OFF LEVEE ROADS.** Motor vehicle parking is available at bridges and at select places along levee roads.
- **PARKING MUST ALLOW OTHERS TO PASS. MOTOR VEHICLES BLOCKING LEVEE ROADS OR ACCESS GATES WILL BE TOWED AT THE OWNER'S EXPENSE.**
- **ALL GATES MUST BE IMMEDIATELY LOCKED AFTER THE PERMITTEE ENTERS OR LEAVES.**
- Violation of the Bosque Access rules may result in loss of the access permit, key, and future permitting and be subject to prosecution under applicable local, state and federal laws.

- Permit covers children under the age of 18 only when accompanied by an adult. Occupants of vehicles are the responsibility of the Permit holder.
- Access is limited to three (3) hours before sunrise to sunset. Access at any other time is by Special Use License only. No overnight camping.
- Licensed hunters may use shotguns and archery equipment, subject to applicable State laws and regulations. No other weapons or firearms are allowed.
- Paintball activities are prohibited.
- Due to highly flammable conditions, smoking is only allowed inside vehicles.
- No alcohol or illegal drugs are allowed on MRGCD property.
- Littering or dumping trash is strictly prohibited.
- Fires are only permitted in grills provided in developed park sites. Fireworks and explosive devices are prohibited.
- Wood cutting and removal of vegetation without an MRGCD permit. Defacement of the Bosque or MRGCD property is not allowed.
- Permittee and occupants release the Middle Rio Grande Conservancy District from any and all claims for damage to property, personal injury, or death that may arise. Permittee agrees to report any violation of these Rules to the MRGCD at (505) 247-0234.
