RE: MRGCD Licenses

The following license requests were approved by staff for the month of January 2015.

1. Special Use License SP-001-2015 – Special Use License to allow Flatirons, Inc. access to the Rio Grande Bosque & Levee to locate and clear vegetation around Bureau of Reclamation range lines between the Belen Railroad Bridge and San Acacia Diversion Dam.
2. Special Use License SP-002-2015 – Special Use License to allow Pate Construction Company, Inc. access to the Rio Grande Bosque & Levees between the Harvey Jones Flood Control Channel & Montano Boulevard to construct the Middle Rio Grande Restoration Project Phase 2 in accordance with the approved construction plans and specifications prepared by the U.S. Army Corps of Engineers.
3. Special Use License SP-003-2015 – Special Use License to allow Amigos Bravos access to the Williams Lateral, Albuquerque Riverside Drain & Barr Interior Drain to conduct water quality monitoring / sampling in the vicinity of the Valle De Oro National Wildlife Refuge.
4. Special Use License SP-004-2015 – Special Use License to allow El Terrero Construction, LLC to construct NM 556 (A.K.A. Roy Road) roadway improvements. The Licensee shall extend an existing 48"Ø road culvert crossing per the approved NMDOT plans and specifications.
5. License 3-091-2014 – License with Public Service Company of New Mexico to install and maintain an aerial electric service line crossing across the Chical Lateral Right-of-Way, Station 514+30±.
6. License 4-093-2014 – License with Centurylink to install and maintain a buried 6 pair telecommunications service line crossing across the Sarracino Lateral Right-of-Way, Station 10+00±.
7. License 2-095-2014 – License with State of New Mexico Facilities Management Division to install and maintain a buried 14KV electric cable crossing across the Alameda Lateral Right-of-Way, Station 445+50±.

8. License 1-002-2015 – License with Santo Domingo Tribe to install and maintain a buried 6"Ø waterline crossing across the Cochiti East Side Canal Right-of-Way, Station 478+40±.
9. License 2-003-2015 – License with Comcast Cable to install and maintain a coax cable crossing within two 2"Ø HDPE conduit across the Armijo Acequia (A.K.A. Ranchos de Atrisco), Station 26+40±.
10. License 2-007-2015 – License with Jack A. & Norma J. Spilman for temporary ingress / egress along the westerly outside 15' of the Derramadera Wasteway Right-of-Way, Station 4+05± to 5+65±.
