PURPOSE OF THIS REQUEST FOR BID (RFB)

PROJECT OVERVIEW

This Sampling and Analysis Plan for summer and fall 2016 fisheries monitoring of select wasteway and drain outfalls in the Isleta Reach provides field personnel with detailed instructions on sampling locations, field equipment operations, monitoring methodologies, and operating procedures.

The drain outfalls in the Middle Rio Grande may provide refugial habitat for fish including Rio Grande Silvery Minnow (RGSM), when river flows are low and/or when river drying occurs. When the river experiences drying or very low flows, drain outfalls can be some of very few if any areas along the river that remain wet or have appropriate water temperature and velocity for fish. A refuge implies that it is a temporary habitat and not necessarily the most suitable for RGSM, but may increase survival when there is no other wetted area It is possible that fish have used these drains as refuge for quite some time, especially when historic river drying was more extensive prior to current water management. They also may become increasingly important as consecutive drought years continue and possibly increase in severity and overbank flooding, oxbows, and backwater habitats continue to decline. There have been several studies done on fish assemblages in the drains. One study found a high number of fish species (18) in the Peralta canal and 122 RGSM when the Isleta Reach was dry in the summer of 2004 suggesting that irrigation canals can function seasonally as refugial habitats for fish (Cowley et. al 2007). This study and others (Lang and Altenbach, 1994; Wesche et. al, 2010; Archdeacon et. al, 2013; SWCA 2014 & 2015) have also found high numbers of fish species including RGSM in the drain outfalls. Based on the higher number of young of year RGSM in Alejandro in 2015, it is also possible that RGSM may spawn in certain outfall locations. This study is intended to add to the knowledge about habitat suitability and fish use of the drain outfalls.

PROJECT GOALS AND OBJECTIVES

Fisheries monitoring of wasteway and drain outfalls to be conducted during summer and fall 2016 is intended to:

- Document drain outfall and adjacent river fish communities by conducting presence/absence sampling to determine relative abundance of fish species.
- Document habitat type(s) fish are utilizing and depth and velocity of areas sampled
- Document water quality and invertebrate utilization as a measure of habitat quality for native fish
- Document the presence absence of small cyprinids in gut samples of predatory fishes found in the drains (e.g., catfish, bass, and sunfish).

PROJECT METHODOLOGIES

SITE SELECTION

Three primary sites that were sampled in 2014 & 2015 and five alternative drain sites (not sampled in 2014 &2015) have been selected for fisheries monitoring during summer and fall 2016

(Table 1). A minimum of three sites will be monitored on each sampling date(s), depending on river conditions and rate of drying.

FISHERIES SAMPLING

Fisheries monitoring will occur weekly to monthly during June through October 2016 depending on site and river conditions. A maximum of 4 surveys will be conducted at each of the selected primary sites. No more than one survey will be conducted at each site per sampling week. Ideally, surveys will be conducted every 14 to 21 days with no more than one survey occurring at each site within 14 days.

Multiple methods for sampling fish are proposed which will allow for an adaptive sampling approach that provides flexibility that can be adjusted to maximize capture efficiency depending on environmental variability (flow, habitat complexity etc.) within in the drain sites. Unlike the main channel, the drain sites proposed for sampling vary considerably both within and among each other and may require a variety of sampling techniques to maximize capture of fishes therein.

BEACH SEINE

A beach seine may be used to sample wasteways (depending on channel conditions) and the adjacent main channel during surveys. All collected fish will be held in aerated buckets for processing. The distance of each seine haul will be recorded and maximum of 20 seine hauls will be collected from each wasteway while a maximum of 10 will be collected the adjacent river channel (30 maximum per site and the adjacent river channel). Sampling locations within a drain site or adjacent main channel will be selected depending on the available habitat and those habitats where capture is likely to be greatest will be sampled. No attempt to sample randomly at drain sites will be made since our objectives are to document presence/absence of silvery minnow and the MRG fish community and not relative abundance.

The wasteway/drain areas will be considered the entire drain area up to the confluence with the main

channel. The adjacent main channel will be sampled from the drain confluence downstream approximately 50 meters or for the entire wetted distance if it is less than 50 meters. A maximum of 20 samples will be collected from the wasteway/drain area and a maximum of 10 samples will be collected from the adjacent river channel.

ELECTROFISHING

A backpack electrofisher and beach seine may be used to sample wasteway drain outfall portions only. A backpack electrofisher (LR-24, Smith Root, Inc. Vancouver, Washington) in combination with a beach seine will be used to sample fish. If flow through the wasteway is sufficient to drift stunned fish then, electrofishing samples will be collected by sampling downstream into the beach seine which will be held stationary by field staff. Stunned fish will drift into the beach seine where they will be collected and placed into aerated buckets for processing. Each combination of beach seine and electrofishing will be conducted over 10 meter long sample areas and maximum of 10 samples will be collected from each wasteway site drain outfall portion (10 maximum/sites).

If flow is not sufficient to drift stunned fish then electrofishing will occur within a minimum of three sampling locations within each drain over an area not to exceed 100 linear meters. When electrofishing is conducted singly without the use of a block nets, a pass will constitute electrofishing from downstream to upstream. Stunned fish will be immediately captured with dip nets, placed into aerated buckets and processed when each sampling pass is completed.

FYKE NETS

Fyke nets may be placed within areas too deep to effectively sample with electrofishing or a beach seine. Two large pool areas within Alejandro and Lower Peralta 2 have been identified that may be more efficiently sampled with fyke nets than with the backpack electrofisher or beach seine. In addition, a fyke net may be placed at the downstream of each drain prior to sampling to intercept fish that may attempt to leave the drain during sampling with the beach seine and the backpack electrofisher.

WATER QUALITY AND ENVIRONMENTAL MONITORING

On each sampling date, water quality measurements will be collected from each wasteway and the adjacent main channel. A minimum of 3 water quality samples will be collected from wasteway area and the adjacent main channel. Water quality will be collected after fish sampling to minimize disturbance to the site and habitat occupancy by fish occupying the site. Water quality parameters will be measured using an YSI 556 multi-parameter handheld meter (Yellow Springs Instruments, Yellow Springs, Ohio), and included temperature (°C), dissolved oxygen (mg/L and %), conductivity (μ S/cm^c [conductivity corrected to 25°C], and μ S/cm [uncorrected]), salinity (parts per thousand), pH, and turbidity (Formazin turbidity units). Water depth (feet) and flow velocity (ft/s) will be measured using a USGS top-setting wading rod fitted with a Marsh-McBirney Flo-Mate portable flowmeter (Hach, Loveland, Colorado). Habitat types of areas sampled and where silvery minnow are found will be recorded to determine if habitat preferences are consistently observed.

SAMPLING ASSUMPTIONS TO MINIMIZE COLLECTION IMPACT

Sampling for fish in wasteways will not be conducted at temperatures at or above 30°C. Prior to sampling at each wasteway or the adjacent main channel temperature will be recorded to determine suitability for sampling. If the temperature is at or exceeds the threshold temperature of the 30°C the survey will be postponed and or another of the selected wasteways will be sampled.

If the density of silvery minnow in a wasteway and the adjacent main channel exceeds four fish per sample or seine haul, or a total of 40 per wasteway site and the adjacent main channel then beach seines

will be the only gear type employed for sampling at that site during additional surveys. Results will be communicated with the USFWS to determine a suitable sampling frequency and avoid overlap with rescue/salvage activities in the area to minimize impacts to silvery minnow.

FISH PROCESSING AND HANDLING

All collected fish will be held in aerated buckets for processing and the temperature of the bucket will be monitored to ensure that it does not reach or exceed the 30°C threshold for sampling. All fish will be identified to species and counted. If silvery minnow are collected then they will be processed immediately and returned to capture location to minimize stress to the species. Collected silvery minnow will be measured for standard length (mm), visually inspected for the presence of hemorrhagic lesions, parasites, anemia and fungal infections. Handling time of silvery minnow will be minimized and restricted to less than 30 seconds per fish to reduce stress. After processing, fish will be released to the area (wasteway or main channel) where they were captured. No fish will be transported away from location of capture. All collected fish will be identified in the field using taxonomic keys provided in Sublette et al. (1990); phylogenetic classification followed Nelson et al. (2004).

DEPLETION SAMPLING (optional)

During the planned August or September survey, a depletion sample may be conducted at one of the proposed drain outfall monitoring sites. The depletion survey will be conducted by closing a 30 meter site with block nets and then depleting the fish population therein with either the backpack electrofisher or the beach seine, depending on environmental conditions. At each depletion survey area, a minimum of 3 and a maximum of 5 passes will be conducted to determine abundance within the depleted area. At the drain site a maximum of 3 depletion samples, each 30 m in length, will be conducted. These data will be used to extrapolate out the density of fish within the drain for all species encountered.

SPAWNING MONITORING (optional)

During the spring (April through June) of 2017, spawning monitoring may be conducted at one to three of the proposed drain outfall monitoring sites. The spawning monitoring will be conducted by using either a Moore Egg Collector (MEC), fyke nets, dipnets, or a combination of methods depending on environmental conditions. RGSM and/or RGSM eggs will be enumerated and released on site.

PREDATORY FISH GUT SAMPLING (optional)

Pulsed gastric lavage (Foster 1977) will be used to flush stomach contents of predatory fish 100 mm or larger. Stomach contents will be flushed onto a measuring board fitted with a Nytex (250 μ m aperture) netting receptacle. For each stomach sampled collected, it will be noted if fish were presence or absent. If stomach samples contain a fish they will be placed into Whirl-Pak sample bags and preserved in 80% ethanol for fish identification in the lab.

INVERTEBRATE SAMPLING (optional)

Hester-Dendy plates will be placed in each of the drain outfall sites at the beginning of the study and taken out and the end to determine macroinvertebrate species composition in the drain outfall sites. A total of three Hester-Dendy plates will be placed (one at each of the primary wasteways) in wasteways.

APPENDIX 2 SUSPENSION AND DEBARMENT REQUIREMENT
