## AGENDA ITEM NO. 1 – PLEDGE OF ALLEGIANCE

Madam Chair led the pledge of allegiance.

#### AGENDA ITEM NO. 2 – APPROVAL OF THE AGENDA

Madam Chair asked for any changes to the agenda and there were none.

AGENDA ITEM NO. 4 – CONSIDERATION/APPROVAL OF DEPARTMENT OF FINANCE AND ADMINISTRATION INFRASTRUCTURE CAPITAL IMPROVEMENT PLAN RESOLUTION #M-09-24-21-172 – Mike Hamman, Chief Engineer/CEO and Pamela Fanelli, CMA, CGFM

Mike Hamman explained the MRGCD is considered a special district at the State and has never formalized an Infrastructure Capital Improvement Plan (ICIP) with the Department of Finance and Administration (DFA) previously. An ICIP is a plan that establishes planning priorities for anticipated capital projects. Mr. Hamman stated that their work with the NM Interstate Stream Commission (NM ISC) to marry several projects of great importance of federal programs and

funding that will be coming to New Mexico, i.e., the Bernalillo to Belen Levee Project. MRGCD is concerned with addressing the cost share components which is approximately one-third of a billion dollars and 35% will have to paid by local sponsors and its associated partners. NM ISC is the primary partner and the Water Trust Board, etc. Rolf Schmidt-Peterson with NM ISC requested that the District have a formal ICIP that mirrors their requests. He mentioned the deadline to submit to the DFA is Monday, September 27, 2021.

Pamela Fanelli added that the ICIP is that the MRGCD can plan for, fund, and develop infrastructure at a pace that sustains their activities annually; which will be for Fiscal Years 2023 through 2027. She said that its submitted to the local government division through the DFA at the State. She reported the benefits of this ICIP, which she and Judy (McSweeney) researched and received an extension of the deadline. Ms. Fanelli said the elements of the ICIP are completion certification form, permission for access form and the resolution of approval. In addition to that, the MRGCD must add the projects into the state website including the project's description, budget and timeline which Jason (Casuga) did a great job compiling the information.

Further discussion was had. Chair Dunning said that the Department of Finance and Administration has full day training sessions and it's her hope that we can attend next year.

M-09-24-21-172 WHEREAS, the Board of Directors ("Board") of the Middle Rio Grande Conservancy District ("District") met in special session at 1931 Second Street, SW, Albuquerque, NM 87102 at 9:30 a.m. on September 24, 2021, as required by law; and WHEREAS, the District recognizes that the financing of public capital projects has become a major concern in New Mexico and nationally: and WHEREAS, in times of scarce resources, it is necessary to find new financing mechanisms and maximize the use of existing resources; and WHEREAS, systematic capital improvements planning is an effective tool for communities to define their development needs, establish priorities and pursue concrete actions and strategies to achieve necessary project development; and WHEREAS, this process contributes to local and regional efforts in project identification and selection in short and long range capital planning efforts. NOW, THEREFORE, BE IT RESOLVED by the Board that: 1. The District has adopted the attached Infrastructure Capital Improvements Plan, and 2. It is intended that the Plan be a working document and is the first of many steps toward improving rational, long-range capital planning and budgeting for New Mexico's infrastructure.
