### AGENDA ITEM NO. 1 – PLEDGE OF ALLEGIANCE

Vice Chair Russo Baca led the Pledge of Allegiance at today's meeting.

Vice Chair Russo Baca declared a quorum, and the meeting was publicly noticed. She also stated who was in attendance noting Chair Dunning and Director Joaquin Baca were absent.

#### AGENDA ITEM NO. 2 – APPROVAL OF THE AGENDA

Director Kelly made the **MOTION TO APPROVE THE MEETING AGENDA**. Director Barbara Baca seconded the motion. The **MOTION CARRIED**.

### <u>AGENDA ITEM NO. 3 - WATER AVAILABILITY REPORT - Anne Marken, Water Operations</u> Division Manager

Anne Marken gave an update on the water supply conditions, that water supply conditions will be difficult this upcoming season. Snowpack levels in the upper watershed are tracking between 85% and 91% of median level. The three month outlook put out by the National Weather Service's Climate Prediction Center, predict warmer and drier conditions through April. The MRGCD does not have the ability to store native Rio Grande water to augment the lower summer flows after the spring runoff is over. In addition to these difficult supply conditions, New Mexico carried approximately 127,000 acre feet of Rio Grande Compact Debt in 2022. Going into the season, the water bank will be closed to all properties that have severed or do not have a water right as per the water bank curtailment policy on accrued Rio Grande Compact debt. Except for properties that have an approved alternate curtailment, irrigators have up until their first irrigation to complete their alternate curtailment.

Vice Chair Russo Baca asked if taking up the 50% of the river was for this season only. Ms. Marken answered yes, it is just specific to this irrigation season. Mr. Casuga concurred.

## AGENDA ITEM NO. 4 - MRGCD IRRIGATION/WATER BANK COMMITTEE REPORT & RECOMMENDATIONS ON WATER BANK LEASE RATES & FEES - Vice Chair Russo Baca and Directors Sandoval & Duggins

Vice Chair Russo Baca stated the administration fee at \$100 per lease for five years, subject there are no changes to the water bank contract. She also said the water service charge per acre would be staying \$43.82 per acre per year, and lease rate per acre is \$50 per acre per year. Vice Chair Russo Baca mentioned that if someone has a water right they can transfer to water bank property, that is an option.

Director Kelly inquired on the number of Alternate Curtailments for 2021. Estella Gamboa, Assessments Clerk, reported that there were 46 constituents enrolled.

WHEREAS, the Board of Directors (Board) of the Middle Rio Grande Conservancy District (District), has reviewed a recommendation from the Board's Water Bank Committee for the fees for the 2022 irrigation season; and

WHEREAS, at a Special Meeting of the Board held February 14, 2022, called for the purpose of establishing Water Bank Rates and Fees, the Board approved the following for the 2022 irrigation season:

Administration Fee

\$100.00/per lease (for 5 years subject to "NO" changes to Water Bank Contract)

Water Service Charge (per acre)

\$43.82 per acre / per year

Lease Rate (per acre) \$50.00 per acre / per year

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Governing Body of the Middle Rio Grande Conservancy District, hereby approves the fees and lease rates for the Water Bank hereinabove described.

RESOLVED: in session this 14th day of February 2022.

Director Duggins made the MOTION TO APPROVE THE ADOPTION OF THE WATER BANK RATES AND FEES FOR THE 2022 IRRIGATION SEASON. Director Kelly seconded the motion. The MOTION CARRIED.
