1. A non-refundable Turnout application fee of Fifty (\$50.00) Dollars at the time of application submission for new turnout installation or Turnout upgrade.
2. Applicant shall bear the cost of the turnout and its installation by the MRGCD per required specifications.
3. Turnouts will be sized and installed in conformance with provision of the Turnout Policy and Water Distribution Policy to achieve MRGCD irrigation efficiency policy of one (1) acre per hour.
4. In case it becomes necessary to construct additional field head ditches to efficiently irrigate lands from the single turnout, Applicant hereby agrees to construct such field head ditches as required at the Applicant's expense.
5. Applicant acknowledges he/she has read and understands the MRGCD Turnout Policy and Water Distribution Policy.
6. MRGCD shall maintain ownership and authority for the use of the Turnout.

FARM TURNOUT POLICY

A new farm turnout installation program is being initiated for the issuance of turnouts to serve the benefited lands of the Middle Rio Grande Conservancy District (MRGCD). The new program takes into consideration the MRGCD Farm Turnout Policy, Irrigation Delivery Policy, On-farm irrigation efficiencies, irrigation scheduling and water delivery operations. A payment of fees and charges will be required prior to the installation of turnout gate.

APPLICATION INSTRUCTIONS

1. Turnout applications must be submitted with a Non-Refundable \$50 Application Fee.
2. Turnout applications must be submitted prior to November 1st, in order to be constructed by the following Irrigation Season. Upon receipt of the application the MRGCD will perform an extensive field Inspection prior to approving, quoting and scheduling.
3. Water Service Charge and/or Water Bank Fees due on this property must be paid in full.
4. MRGCD will communicate with the Applicant a recommended turnout gate size, location and specifications for turnout installation.
5. MRGCD will prepare a quote for the applicant after the final field inspection and size of turnout has been finalized.
6. Full payment will be required in advance prior to scheduling and installation.
7. All turnouts are the ownership of the MRGCD who has authority for use of turnouts.
8. Submit the application to the MRGCD.
9. **Acknowledgment: By signing the application, I am acknowledging that I have read and understand the MRGCD Turnout Policy, Water Distribution Policy and Application Instructions. If this application is approved, I also agree to accomplish the specified directives that have been designated that are required for irrigation efficiency.**
