**RESOLUTION OF THE BOARD OF DIRECTORS
OF THE MIDDLE RIO GRANDE CONSERVANCY DISTRICT**

**ADOPTION OF WATER SERVICE CHARGE RATE PER ACRE FOR
THE 2025 IRRIGATION SEASON**

WHEREAS, staff presented the 5-year forecast in the January 2025 board meeting and determined that an increase in Water Service Charges is necessary; and

WHEREAS, at a Special Meeting held February 10, 2025, the Board of Directors (Board) of the Middle Rio Grande Conservancy District (District) has reviewed a recommendation from staff regarding a Water Service Charge increase of \$8.00 per acre for the 2025 irrigation season; and

WHEREAS, the Board has determined that the water service charge will be increased for the 2025 irrigation season as follows:

Water Service Charge (per acre)
\$59.25 per acre/ per year

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Governing Body of the Middle Rio Grande Conservancy District. hereby approves the water service charge of \$59.25 per acre for the 2025 irrigation season.

RESOLVED: this 10th day of February 2025, in a duly convened session of the Board.
